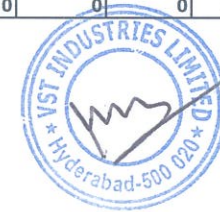

Note :

The Company currently falls under the category of a FDI Prohibited Sector- as it is in the business of Manufacturing Cigarettes. This prohibition was effective from 2010.

The Company has been operating since 1930. The Promoters of the Company are Foreign Body Corporates and the Company had obtained relevant permissions from the RBI for its current promoter holding of 32.16% prior to the prohibition coming in to place and which is reflecting in Table II (2)(e).

Other holdings, reflecting under Approved limits in Table VI pertain to the investment limits for Foreign Portfolio Investors and Non-Resident Indians as allowed under the e Foreign Exchange Management (Non-debt instruments) Rules, 2019.
